The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following Violation of the law: On the 12th day of March 2023 at 3:00 AM. PM (Specially include facts constituting cause for arrest)

Your Affiant is Inspector Kevin Stout (Inspector Stout) with the Office of the Inspector General for the Florida Department of Corrections, and the defendant is Inmate Michael Grimace (Inmate Grimace), DC #415545 who is currently assigned to Columbia Correctional Institution. Your Affiant has investigated a Battery on a Law Enforcement Officer and Lewd and Lascivious Exhibition in the presence of an employee, which occurred at Columbia Correctional Institution, Main Unit.

On March 12, 2023, at approximately 3:14 am, Correctional [REDACTED] [REDACTED] [REDACTED] called for assistance in A dormitory due to Inmate Grimace masturbating while sitting on a toilet in the inmate bathroom while looking at [REDACTED]. Correctional [REDACTED] [REDACTED] [REDACTED] responded and when he entered the dormitory, Inmate Grimace was still in the bathroom area. [REDACTED] informed Inmate Grimace he was being issued a Disciplinary Report (DR) for Lewd and Lascivious Exhibition and proceeded to the rear portion of the bathroom toward Inmate Grimace. While in the bathroom, [REDACTED] ordered Inmate Grimace to turn around and submit to hand restraints. Inmate Grimace refused to cooperate nor submit to hand restraints causing [REDACTED] to retrieve his chemical agent. Upon [REDACTED] administering the chemical agent, Inmate Grimace began to physically fight by striking [REDACTED] with numerous hand and fist strikes to multiple areas of his torso and head area. [REDACTED] attempted to assist [REDACTED] and was exposed to chemical agent which limited her ability to physically apply hand restraints. During the altercation, Inmate Grimace took [REDACTED] chemical agent canister and began spraying the chemical agent toward [REDACTED] and [REDACTED]. [REDACTED] called for assistance.

Inspector Stout reviewed the dormitory fixed wing camera footage and observed [REDACTED] followed by [REDACTED] enter the bathroom area, and make contact with Inmate Grimace. [REDACTED] begins to back away

from Inmate Grimace while retrieving his chemical agent canister. [REDACTED] administered chemical agent, which resulted in Inmate Grimace running at and grabbing [REDACTED] in his torso area while punching and striking [REDACTED]. During the altercation, both [REDACTED] and Inmate Grimace fall to the floor and stand back multiple times. [REDACTED] and Inmate Grimace move to the hallway exit door [REDACTED].

Your Affiant respectfully submits probable cause has been established to support Inmate Michael Grimace did commit two (2) counts of Battery on a Law Enforcement Officer in violation of FSS 784.07(2)(b), and one (1) count of Lewd or Lascivious Exhibition in Presence of a Correctional Facility Employee in Columbia County, FL at Columbia Correctional Institution Main Unit, on March 12, 2023. Your Affiant respectfully requests a warrant be issued for Inmate Michael Grimace for two (2) counts of FSS 784.07(2)(b), Battery on a Law Enforcement Officer, and one (1) count FSS 800.9, Lewd or Lascivious Exhibition in Presence of Correctional Facility Employee.

All supporting documents and videos will be available for judicial review and will be further explained in your affiant's report of investigation.
