Once the wing door was opened, Inmate Crenshaw exited the wing, into the Sallyport area, and attempted to exit the dormitory. A Use of Force occurred with chemical agents due to Inmate Crenshaw refused to comply with verbal commands. Inmate Crenshaw was placed on the floor and was placed in hand restraints after a brief struggle. At no time did or Sergeant Molinski get struck by Inmate Crenshaw.

Inmate Crenshaw was arrested by LSI McGauley and transported to the Hamilton County Jail by Deputy Yenson Gonzalez (*Deputy Gonzalez*).

Your Affiant respectfully submits probable cause has been established indicating Inmate Crenshaw struck with a lock while he was acting in the capacity of a Correctional Officer. Inmate Crenshaw is in violation of Florida Statute 784.07(2)(d) for the crime of Aggravated Battery on a Law Enforcement Officer, committed at HCI-A, located in Hamilton County, Florida within the jurisdiction of the Third Judicial Circuit.
