The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above-named Defendant committed the following Violation of the law:  
 On the 23rd day of June 2022 at approximately 4:50 P.M. (Specially include facts constituting cause for arrest)

Your Affiant is Inspector John Tadlock with the Office of Inspector General for the Florida Department of Corrections. The Defendant is Oraine MitchellGrant (*Inmate MitchellGrant*) DC# S61552, who was housed at Liberty Correction Institution (LCI) at the time of this incident.

Your Affiant has investigated the criminal violations of Battery on a Law Enforcement Officer and Resisting an Officer with Violence.

The two (2) victims, Correctional Officer [REDACTED] and Correctional Officers [REDACTED] both testified in summary that [REDACTED]

Fixed-wing video obtained from the security camera located in [REDACTED] at LCI, on June 1, 2023, captured Inmate MitchellGrant viscusly and repeatedly punching [REDACTED] and [REDACTED] multiple times with a closed fist. [REDACTED] and [REDACTED] were both clearly wearing recognizable correctional officer uniforms and appeared to be performing their normally assigned duties.

An attempt was made to interview Inmate MitchellGrant who invoked his right to remain silent.

Your Affiant respectfully submits probable cause has been established indicating Inmate MitchellGrant battered [REDACTED] and [REDACTED] while acting in the capacity of a Correctional Officer, and that Inmate MitchellGrant knowingly and willfully resisted by physical force [REDACTED] and [REDACTED]

during the performance of their sworn duties. Inmate Mitchell Grant is in violation of Florida Statute 784.07(2)(b) for two (2) counts of the crime of Battery on a Law Enforcement Officer and Florida Statute 843.01 for one (1) count of the crime of Resisting an Officer with Violence, committed at LCI, located in Liberty County, Florida within the jurisdiction of the Second Judicial Circuit.

Your Affiant respectfully requests a NO BOND hold on Inmate Mitchell Grant for the above listed charges.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
