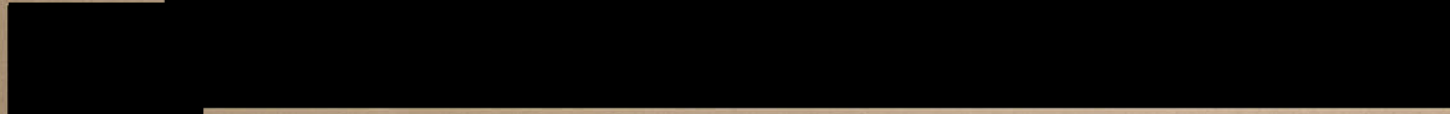

The Undersigned Certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above-named Defendant committed the following Violation of the law:
On the 16th day of July, at 3:00 AM PM (Specially include facts constituting cause for arrest)

Your Affiant is Inspector Heather Whitfield with the Office of Inspector General for the Florida Department of Corrections, and the Defendant is Yanicka Knox. Your Affiant has conducted an investigation into, Possession of a Fraudulent Driver's License at Hamilton Correctional Institution Annex (HCI).

On July 16, 2023, Yanicka Knox produced a Florida Driver's License to enter into Hamilton Correctional Institution Annex to conduct an in person visit with Inmate Eric Allen DC# W11465. The driver's license produced to the control room listed the name Rodshell Geraldine Bailey DOB 08/04/1983. The driver's license number on the top of the card was B230-383-98-645-0. The license was not the current Florida style despite being issued in 2017. Control room staff became suspicious and kept the license and notified Your Affiant. Your Affiant inspected the license and the two-digit number associated with the license did not match the date of birth listed on the license. A check through NCIC / FCIC of the number showed the number on the license produced was not valid. The correct number for Rodshell Bailey listed on the license was different than the one produced.

Your Affiant conducted a post Miranda Interview with Yanicka Knox who was informed of the discrepancies in the license.

Upon securing Inmate Eric Allen after visiting with Yanicka Knox, Inmate Eric Allen relinquished 26.2 Grams with packaging of marijuana and 17.2 Grams of Cocaine that was wrapped in black electrical tape. A post Miranda Interview was conducted with Inmate Eric Allen and he [REDACTED]

A review of the fixed wing video was conducted by Your Affiant. Your Affiant observed Yanicka Knox retrieving an item from her genital area under the table and placing the item in the potato chip bag. Immediately following placing the item in the potato chip bag, Yanicka Knox slid the bag over to Inmate Eric Allen where he then took possession of the bag. The fixed wing video also revealed a subsequent package of 51 Grams of Marijuana found that Inmate Eric Allen attempted to conceal before being placed in confinement.

Your Affiant respectfully submits probable cause has been established indicating Yanicka Knox did commit the violation of Possession of a Fraudulent Driver's License 322.212 (1)(a) and Introduction of Contraband (Marijuana) 944.47 (1)(a)(4) in Hamilton County, Hamilton Correctional Institution on July 16, 2023.

All supporting documents referred to in this affidavit will be available for judicial review and will be further explained in your affiant's report of investigation.
