Your Affiant is Lead Senior Inspector Chris McGauley (LSI McGauley) with the Office of Inspector General (OIG) for the Florida Department of Corrections (FDC). The Defendant is Mary Jones (Mrs. Jones) a visitor who attempted to visit Inmate Shannon Green (Inmate Green) DC# 890939, at Liberty Correctional Institution Annex (LCI) on July 23, 2023. Your Affiant has investigated a Possession of Suboxone and an Introduction of Contraband (Conspiracy).

On July 23, 2023, LSI McGauley, Inspector Joey Varnum (Inspector Varnum), and Inspector James Padgett (Inspector Padgett) were at Liberty Correctional Institution (LCI) assisting Florida Department of Corrections (FDOC) K-9 staff and security staff with a checkpoint and visitation. Correctional Officer Captain Justin McDowell (Captain McDowell) conducted a free air sniff (with K-9 Zseton) around the perimeter of a 2023 white Toyota Camry, displaying Florida tag # 20D BWX. Both the driver, Griselle Santiago (Ms. Santiago), and the visitor, Mrs. Jones drove onto state property with the car. K-9 Zseton alerted on the vehicle for the possible presence of narcotics inside it. Consent to search the car was granted by Ms. Santiago, who signed a Consent to Search form.

Your Affiant respectfully submits probable cause has been established, that Mary Jones did commit the offense of Possession of Suboxone in violation of §893.135 1(c)1a, and Introduction of Contraband (Conspiracy) in violation of § 944.47/ 777.04 in Liberty County, Florida, at Liberty Correctional Institution.

All supporting documents and testimony referred to in this affidavit will be available for judicial review and will be further explained in your Affiant's report of investigation.
