

**84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE:** The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant is Senior Law Enforcement Inspector Louis Cordova with the Florida Department of Corrections, Office of Inspector General.

Your Affiant has probable cause to believe on August 2, 2023, at approximately 6:24 a.m., Inmate Tony Brinson (Inmate Brinson), DC#149255, an inmate assigned to Gulf Correctional Institution, in Gulf County, Florida, did commit the criminal offense of Aggravated Battery on a Law Enforcement Officer, in violation of s. 784.07(2)(d) Fla. Stat. Inmate Brinson committed the offense while housed at Gulf Correctional Institution located in Wewahitchka, Florida, when he did actually and intentionally strike Correctional Officer [REDACTED] against her will, while [REDACTED] was clothed in a correctional officer's uniform and engaged in the lawful performance of her duties, and while Inmate Brinson knew [REDACTED] was a Correctional Officer.

Your Affiant obtained sworn testimony from [REDACTED] who indicated [REDACTED]


Your Affiant reviewed the fixed wing video cameras in the Food Service Department. The cameras reviewed were in the [REDACTED]. The video depicted Inmate Brinson strike [REDACTED] multiple times about the face with his closed fists. [REDACTED] was defenseless and did not see the blows coming. [REDACTED] was knocked to the ground face first and [REDACTED]. Correctional Officer Trainee Larry Cannon (Officer Cannon) responded and took Inmate Brinson to the ground until he could be restrained.

Your Affiant obtained sworn testimony from Officer Cannon. Officer Cannon stated on August 2, 2023, he was present in the dining hall and witnessed Inmate Brinson strike [REDACTED] against her will.

In his sworn post-Miranda statement, given on August 2, 2023, Inmate Brinson indicated [REDACTED]

Your Affiant respectfully submits probable cause has been established to conclude Inmate Brinson did commit the criminal violation of Aggravated Battery on a Law Enforcement Officer, in violation of s. 784.07(2)(d) Fla. Stat., by striking [REDACTED] against her will at Gulf Correctional Institution, in Wewahitchka, Gulf County, Florida, on August 2, 2023. In doing so, Inmate Brinson's actions caused [REDACTED]
