84. NARRATIVE OF THE FACTUAL BASIS FOR PROBABLE CAUSE: The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the heretofore named defendant did commit the violations of law as stated above and the factual basis for this belief is as follows:

Your Affiant, Detective Kevin Patterson (Detective Patterson), is a sworn law enforcement officer of the Office of the Inspector General, Florida Department of Corrections (Department).

On November 4, 2023, at Martin Correctional Institution (Martin CI), Martin County, FL, Yuvika Karen Jeanty (Defendant) violated Florida Statute § 893.135 (k)(1), Trafficking in Phenethylamines and Florida Statute § 944.47(1)(a)(4), Possession of Drug Contraband, while on Department's property at Martin CI.

During a contraband introduction operation with the Department's Canine Interdiction Unit, a certified canine alerted to the presence of the odor of narcotics which emanated from a marron Toyota Camry, bearing FL license plate number 55DNLN. After the alert and a period of delay to identify the driver, the Defendant came to the parking lot.

Detective Gregory Elias (Detective Elias) approached the Defendant and secured written consent to search the vehicle in the institution's parking lot. Detective Patterson and Canine Introduction Unit personnel searched the vehicle. During the search, Detective Patterson discovered a purse in the truck of the vehicle. The Defendant claimed ownership of the purse. Upon searching the purse, Detective Patterson discovered an oval item wrapped in black electrical tape. A box of condoms, one of which was opened, was also located in the purse.

Upon examination of the oval item, it contained a white powdery substance and weighed (64.6) grams. Detective Patterson tested the substance with a presumptive narcotic field test. The test yielded a positive result for substituted cathinones (Bath Salts).

During a post-Miranda statement, the Defendant
