Your Affiant is Law Enforcement Detective Maria Fender (Detective Fender) with the Office of Inspector General for the Florida Department of Corrections. The Defendant is Mr. Ruben Perez (Mr. Perez). Your Affiant has investigated a case involving Sexual Misconduct between the Defendant and an incarcerated inmate; while the Defendant was working as a Maintenance Squad Supervisor at Gadsden Correctional Facility, a privately owned Correctional Institution, contracted by the Florida Department of Corrections.

On June 14, 2023,		an Inmate housed at Gadsden Correctional Facility from

On Monday, June 12, 2023, both the Victim and the Defendant were located inside the maintenance bay located at Gadsden Correctional Facility where they engaged in oral and vaginal intercourse culminating with the Defendant ejaculating inside the Victim's vagina.

The Victim was documented, photographed, and collected evidence from the victim. The collected evidence was submitted to the Florida Department of Law Enforcement (FDLE) Crime Lab for Forensic Analysis and presented a positive DNA result for the presence of a mixture consistent with two donors, including at least one male.

A Search Warrant was obtained and executed for the purposes of collecting the Defendant's DNA via Buccal Swab for forensic comparison. The results returned a positive finding, identifying the Defendant as the cocontributor to the DNA evidence.

Your Affiant respectfully submits probable cause has been established that the Defendant, Mr. Ruben Perez committed the criminal violation, of Sexual Misconduct in Violation of §944.35(3)(B)(2) Florida State Statute; with an Inmate while employed at Gadsden Correctional Facility in the city of Greensboro, located in Gadsden County, Florida.
