PM (Specially include facts constituting cause for arrest) Your Affiant is Detective Joseph Varnum (Detective Varnum) with the Office of Inspector General (OIG) for the Florida Department of Corrections (FDOC), and the defendant is Correctional Officer Mayci Bunkley (Officer Bunkley) who was employed at Liberty Correctional Institution (LCI). Your Affiant has investigated Sexual Misconduct where two contraband phones were discovered at LCI on Inmates DC.# The data extracted from the two phones and had both video and text messaging evidence which indicates the acts of Sexual Misconduct between Officer Bunkley and (see below). The contraband cellular device recovered from possession was priority extracted by GTL Fusion Services (FDC contracted cellular telephone lab), a review of the extraction report was conducted by Inspector Varnum and detailed the following dates and texting conversations between Officer Bunkley and while they discussed being involved sexually.
