NARRATIVE: The undersigned has probable cause to believe the above-named defendant on the 24 of January 2024 at 12:30 at CFRC (Zone: region 4) in Orange County did

Your Affiant is Inspector David Rausch of the Office of Inspector General, the Florida Department of Corrections (FDC).

Your Affiant has probable cause to believe the Defendant (Civilian FDC Contractor Raven Richmond) did commit the criminal offense of Introduction of Contraband into a State Institution, in violation of F.S.S. 944.47(1)(a)4 when she introduced 8 grams of packaged weight Cannabis and 4 grams packaged weight of Oxycodone pills, at the Central Florida Reception Center (a state correctional institution) on January 24, 2024, at approximately 12:30 p.m.

Your Affiant has probable cause to believe the Defendant (Civilian FDC Contractor Raven Richmond) did commit the criminal offense of possession of Hydrocodone, a schedule 2 controlled substance, in violation of F.S.S. 893.13(6)(a) when she possessed 4 grams of packaged weight Oxycodone pills, at the Central Florida Reception Center (a state correctional institution) on January 24, 2024, at approximately 12:30 p.m.

At the time of the incident, the Defendant was a government contracted employee (Trinity) working at the Central Florida Reception Center, a state correctional institution.

During a sworn audio recorded interview on January 24, 2024, Correctional Officer Kenneth Foster (Officer Foster) stated he was working at the rear gate of the Central Florida Reception Center when the Defendant drove a work cart with supplies through the first rear security gate. The Defendant then stopped the work cart and got off so the work cart could be searched and inspected per institution policy. When Officer Foster was conducting his inspection and search, he observed a red jacket on the driver's side of the work cart that the Defendant was driving. When Officer Foster picked up the jacket a Doritos chip bag fell out of the jacket. Officer Foster then tried to crunch the bag, but it did not crunch. When Officer Foster looked into the chip bag, he observed an item wrapped in tinfoil which had a strong odor of Cannabis.

Officer Foster then confiscated the Doritos chip bag and notified his chain of command. When Officer Foster opened the Doritos bag it contained alleged Cannabis and unknown pills.

The alleged Cannabis was field tested by Correctional Sergeant Marcus Hunt (Sergeant Hunt) in the presence of your Affiant. The Cannabis tested positive for THC and weighed 8 grams packaged weight. The pills were stamped "M" on one side and "30" on the other side. According to Drugs.com that stamp belongs to Hydrocodone pills. Pictures of the field tests and substances were taken and preserved for the record.

Your Affiant received fixed wing video which shows the entrance to the rear security gate. The video shows the Defendant driving a work cart through the rear gate. The video then shows the Defendant park the work cart, take off a red jacket, place it on the driver's seat, and then walk to the officer station. Officer Foster is then seen doing his inspection and search of the work cart. Officer Foster is seen picking up the red jacket and an object is seen falling from the jacket. Officer Foster then picks up the object and is seen inspecting it.

On January 24, 2024, Your Affiant attempted to obtain a post-Miranda statement from the Defendant, but she exercised his constitutional right to remain silent.

Based on the information gathered, probable cause exists to charge the Defendant with one count of Introduction of Contraband into a State Institution, in violation of F.S.S. 944.47(1)(a)4 and possession of Hydrocodone, a schedule 2 controlled substance, in violation of F.S.S. 893.13(6)(a).

Your Affiant respectfully requests that you find probable cause for the criminal charges listed above.

All supporting evidence referred to in this affidavit, including sworn interviews, pictures, video, and medical reports, will be available for judicial review and further explained in your Affiant's report of investigation.
