Your affiant is Inspector Keith D. Turner of the Office of the Inspector General, Florida Department of Corrections.

Your Affiant has probable cause to believe that on May 4, 2021, at approximately 3:39 PM, Defendant Inmate Octavio Roca DC# Y57082 (Inmate Roca), along with his co-defendant Inmate Sergio Corona DC# M62235 (Inmate Corona), did commit the offense of Aggravated Battery, in violation of ss. 784.045 (1) (a) (1), Fla., Statute and ss. 784.045 (1) (a) (2), Fla., Statute, and Possession of a Weapon, in violation of ss. 944.47 (1) (c), Fla., Statute, when Inmate Roca did intentionally cause great bodily harm to [REDACTED] by attacking and kicking him [REDACTED] multiple times after [REDACTED] had fallen to the floor after Inmate Roca's co-defendant Inmate Corona physically attacked [REDACTED] with a homemade knife and stabbed [REDACTED] multiple times about his [REDACTED] body.

This incident occurred on fixed wing video and was reviewed with the following information obtained:

As [REDACTED] assisted with the inmate evening meal inside the west dining area of the food service building, Inmate Corona and Inmate Roca received their food trays and sat down together at a table. Subsequently, Inmate Corona stood up and approached [REDACTED] and without warning began striking [REDACTED] about his [REDACTED] body with a homemade weapon. As Inmate Corona stabbed [REDACTED] fell to the floor and Inmate Roca approached and began kicking [REDACTED] as [REDACTED] attempted to defend himself against Inmate Corona. Sergeant Scott Thrift (Sergeant Thrift) who was inside the food service building responded to [REDACTED] aid and used force against Inmate Corona by deploying his issued Dart Fired Electronic Immobilization Device (DFEID) to stop the attack against [REDACTED]. Additional security staff responded to the incident location and both inmates were detained.

[REDACTED] was [REDACTED] due to Inmate Corona unprovoked attack.

[REDACTED] provided sworn, audio recorded testimony and stated that [REDACTED]

Sergeant Scott Thrift (Sergeant Thrift) provided sworn, audio recorded testimony that corroborated [REDACTED] account of the incident.

In a post-Miranda recorded interview, Inmate Corona invoked his right to remain silent.

Your affiant has respectfully submits that there is probable cause believe that Inmate Roca did commit the criminal offense of Aggravated Battery, in violation of Florida Statute 784.045 (1) (a) (1) at Cross City Correctional Institution, 568 N.E. Street, Cross City, Florida 32693 and in Dixie County.
