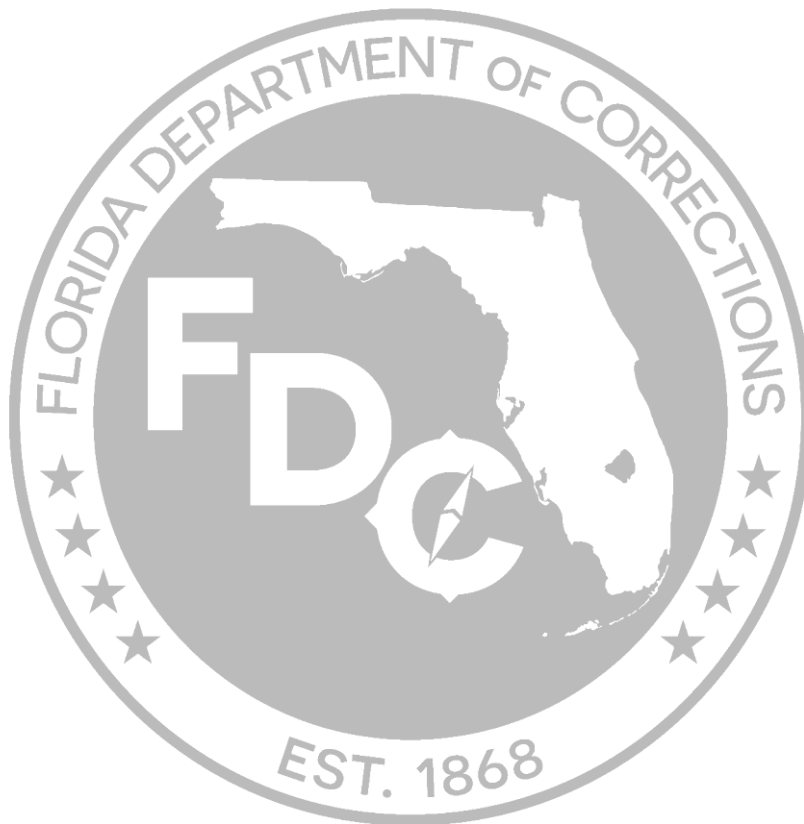

Inmate Profile Summary

This report summarizes county information mandated to be collected by F.S. § 951.23(2) and submitted to Florida Department of Corrections. It provides a monthly profile of inmate populations inside Florida's detention facilities. For counties that can not submit data using standardized instruments it provides approximated data.

Table 1, pages 1 & 2, features the Average Daily Population and incarceration rate in each county.

Table 2, pages 3 & 4, lists the number and percent of felony and misdemeanor pretrial inmates at each detention facility.

The Jail Population Summary (Table 3, page 5) lists detention center totals for the year to date.

Average Daily Population

As reported, there were an estimated 55,381 inmates in Florida's county detention facilities during the month of June 2019. In comparison, in June 2018, there were 55,179 inmates incarcerated by county facilities in Florida. This is a 0.4% increase from last year.

*If June's jail population for a facility was not transmitted at the time this report was published, then population numbers from another month are used in the place of the missing data and the date for these numbers is given. If the information transmitted to the Department did not conform to the standards established by the instrument developed per §951.23(2) , but the month's population average was provided, then "Date Reported" will reflect the current month.

** St. Johns County implemented a temporary outdoor facility in June. Rather than show those numbers in a new report row, separately, as reported, these numbers have been combined in the St. Johns Main Jail Facility in this report. The outdoor facility held approximately 78 inmates per day for 14 days in June, representing approximately 36 beds averaged over the month.
